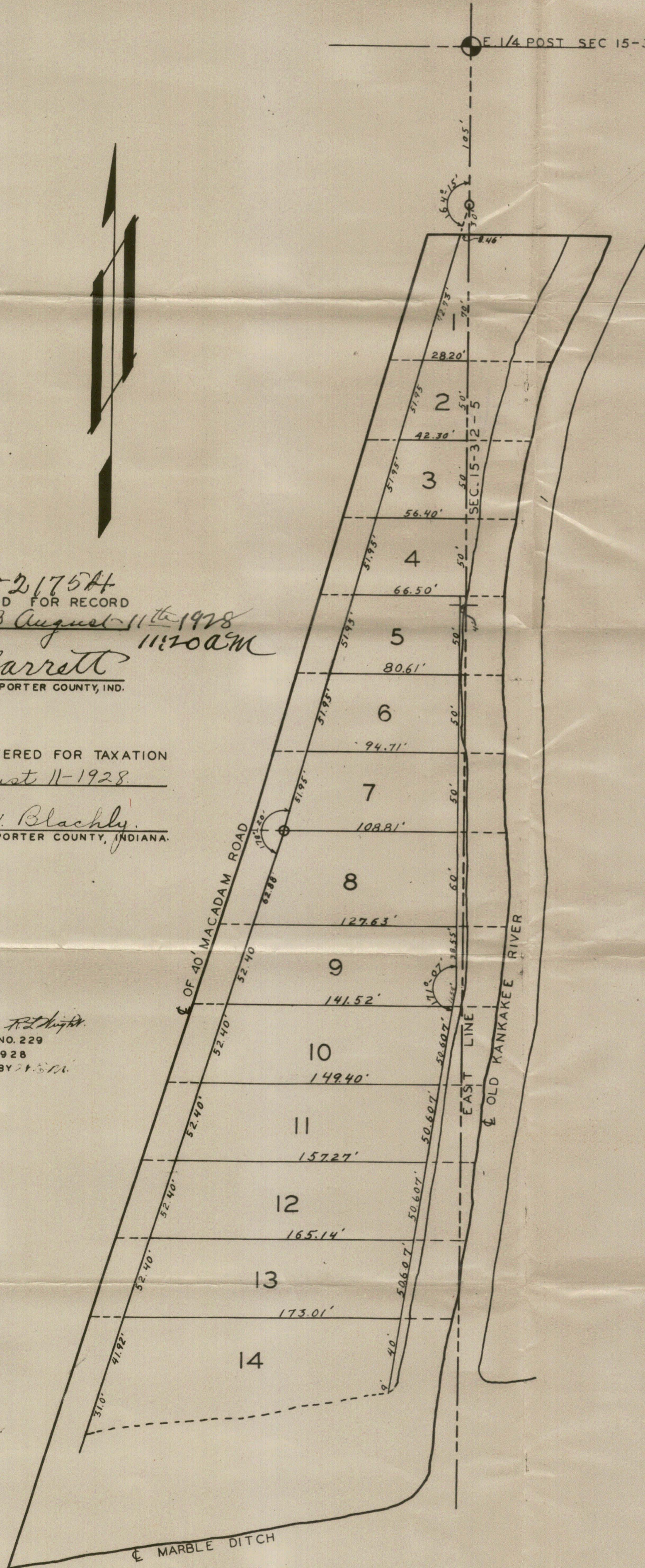

BEING A SUBDIVISION OF THAT PART OF GOV. LOT 4 IN SECTION 14 TWP. 32 N. R. 5 W. AND THAT PART OF GOV. LOT 1 IN SEC. 15 TWP. 32 N. R. 5 W. DESCRIBED AS BOUNDED; ON THE NORTH BY A LINE DRAWN AT RIGHT ANGLES TO THE WEST LINE OF SEC. 14 THROUGH A POINT 135' SOUTH OF THE W. 1/4 CORNER OF SAID SEC. 14; ON THE EAST BY THE CENTER LINE OF THE OLD KANKAKEE RIVER; ON THE SOUTH BY THE CENTER LINE OF THE OLD KANKAKEE RIVER; AND THE CENTER LINE OF THE MARBLE DITCH; AND ON THE WEST BY THE CENTER LINE OF A PUBLIC ROAD. IT BEING THE PURPOSE OF THE SUBDIVIDERS TO SUBDIVIDE ALL THE LAND WHICH FALLS WITHIN THE ABOVE BOUNDARIES, EACH LOT, AS CONVEYED BY DEED FROM THIS PLAT, IS SUBJECT TO EASEMENTS OF PUBLIC HIGHWAY, PUBLIC DITCH, AND KANKAKEE GOV. MEANDER LAND, THE SUBDIVIDERS PARTING WITH ALL RIGHTS AND CLAIMS THEY MAY HAVE WITHIN THE BOUNDARIES OF THE LOT SO CONVEYED FROM THIS PLAT.
